The meeting started at 10:00am. Patricia Oliva welcomed members and partners to the meeting. Roll call of members was taken. Twin Rivers and Washington arrived after the roll call, and Elk Grove was unable to attend the meeting and submitted their votes electronically. ELL Healthcare Pathway Update

- Round three funding will be a competitive RFA with awards between 1 million and 5 million dollars. It will be open to 71 consortia and up to 20 awards will be awarded. The purpose of this funding is to fund Centers of Innovation and Impact in health careers. The expected RFA will be released in mid-fall 2025 with the anticipated award cycle to start during the 26-27 fiscal year. It will be a 36-month expenditure period.
 - Carey Buchanan asked for more details on the requirements.
 - Requirements will probably be different for round 3 than previous rounds. This grant focuses on English language learners developing the skills to go through a healthcare pathway to gather skills for a job in that field.

WIOA Funding and Test Updates

- Preliminary Funding Results have been updated for grantees receiving Section 243 – Integrated English Literacy and Civics Education grant funding. Updates have posted to the [2025–26 WIOA Grant Information web page](#). This information has also been added to [California Adult Education Online Application and Reporting Site](#). Agencies are encouraged to review the information within the reporting site for additional information.
- Preliminary funding will be updated in the next couple of weeks to reflect increased payment points. The value for IET 243 has increased and the new value will be approximately \$1100-1200 per point. GANs are expected by 10/31/25.

Carryover Compliance

- CAERC is currently at 12.21% carryover, which is well under the 20% threshold. We will dive more into these numbers during next week's budget workgroup.

Member and Partner News, Updates, and Challenges

- Pauline Lopez from Sacramento City shared that Holly Clark with the CAEP TAP office is a wonderful resource if members have any questions or are unfamiliar with NOVA reporting/reallocating funds.
- Futures Explored is starting to fundraise due to all the funding cuts. Laura McCrary will share invites to events as they come up. They are working on expanding their creative arts and media programs, and they just opened a program in Concord that teaches adults with disabilities film and media skills.
- An Ta with Yolo COE will be attending the Advancing CA Apprenticeship next week in Riverside. Their next Community of Practice will be held on October 16th. They are trying to regionally provide assistance, aide, and support. The [Gladeo](#) platform is working well for their county, and they are working on scaling it out. An will also be attending the CA Adult Education Institute at Charles A. Jones.
- Laurelle Mathison and her team at Twin Rivers have been trying to tighten up their workforce prep. CalRegional classes will start in January. They've been dealing with an influx of students from Highlands. They've also been trying out the ILA that CAERC purchased and are really enjoying using it at their site.
- Things are going well at Galt. They use FuelEd for high school classes, and it has now switched to a different program, and it's been a hard transition. Joe Schallberger is looking at other options for their high school program. ESL intermediate and higher are at max capacity.
- Folsom Cordova has 300 people on their ESL waitlist, and they're trying to figure out how to support more people with limited funds. They have a lot of preliterate people, and they aren't sure how to pay for those classes.
 - Some suggestions from the group include partnering with the district; partner with FACE (Family and Community Engagement) if the school has one; distance learning; using Putting English to work.
- San Juan is super busy with their ESL classes having 3400 students registered and capacity for only 1500. All of their ESL classes have waitlists. High school registration is where it's normally at, and Richard Judge is still trying to hire someone for GED prep. They don't have the manpower to get through everything but are doing the best they can. They plan on putting a disclaimer on their website.
- EDCOE's ESL numbers are double what they were last year. They have a waitlist for all of their classes, which is unusual. They've been tracking their persistence with trying to get students who've stopped attending and dropping those that aren't responsive.
- Natomas is also at capacity with ESL. They will have cosmetology for 2026-27. High school students are currently able to enroll in it now, but adult ed will be able to enroll in the next program year. This class will be at Discovery High School.
- Davis and Amador both have open availability in their ESL classes if students are willing to travel.
- Washington's ESL classes have waitlists for the first time in years. They've opened 2 additional classes, but they still have a waitlist.
- Rob Kinder at Davis is trying to convince his team to offer virtual classes. They currently have a good number of high school diploma students. They have a huge interest list for their CNA program, but they've had numerous roadblocks in getting that class restarted.

- Stephanie Groat promoted the CCAE awards and let the group know that more information will be coming.
