The meeting started at 1:03 pm. Branka Marceta welcomed members and partners to the meeting. Roll call of members was taken. Thirteen voting members were present at time of roll call (Amador, Davis, El Dorado COE, Elk Grove, Folsom Cordova, Galt, Los Rios, Natomas, Sacramento City, Sacramento COE, San Juan, Twin Rivers, and Washington).  - ED Code section 84909 states that the chancellor and the Superintendent, with the advice of the executive director of the state board of education, shall approve, no later than February 28 of the prior fiscal year, a preliminary allocation to each consortium of funds proposed in the Governor's Budget for the program. The January budget proposal will be available by January 10, 2021.

Fact Sheets: Sacramento City USD Adult Education and San Juan Adult Education

- Sacramento City Unified School District Adult Education's vision is to advance their community's economic, workforce development, and societal goals by preparing adult learners for careers, college, and civic life.
- The numbers on the Sacramento City USD fact sheet represent their two programs, A. Warren McClaskey Adult Center and the Charles A. Jones Career and Education Center (CAJ). 58% of their 1,514 enrolled students are non-native English speakers. The top 2 program areas with enrollment are English Language Acquisition (ESL) and Short-Term Career Education. Two of every three students enrolled are female, but this may change when the regional manufacturing program at CAJ becomes bigger. 97% of their students face 1 or more employment barriers. CAEP funds makes up 26% of their funding sources. 116 vocational training certificates were earned by students in 2019-20.
- San Juan Adult Education's vision is to empower every student to meet his or her learning goals and strengthens their contributions as members of the community.

- Due to COVID San Juan has seen a significant drop in students from 2018-19. In 2019-20 they served 1,997 students which is roughly 600 students less than 2018-19. 80% of students are non-native English speakers and they collectively have over 27 native languages. The top native languages spoken by students are Dari or Pashto (stated as Farsi on the fact sheet), Spanish, and Russian. 99% of students report at least 1 employment barrier. CAEP funds make up 69% of their funding sources. San Juan had 50 students graduate with their high school diploma or equivalency.
- Their Creekside Adult Center was opened a year and a half ago to help with the number of refugees in the area. This location may be changing to a different site in the future.
- Kelly Hunkins asked if San Juan offers any CTE or workforce readiness certificates since that data is not on this sheet. San Juan does offer a medical assisting program along with other hands-on courses, but because of COVID there have been difficulties with reopening. They hope to offer a building inspector program this fall.
- Bethany Ely let the group know that the reason certificates are not shown on the fact sheet is because of a space issue. If this is something that the group thinks needs to be on the fact sheets she can replace something else with this information.

Voting Item: CAERC Shared Fiscal and Budget Policy

- During CAERC Director's Workgroup meetings in the program year 2020-21, officially-designated members discussed amending CAERC's Shared Fiscal and Budget Agreement Policy with the goal to update the document. The following changes were made:
 - Updated the name from Adult Education Block Grant to California Adult Education Program.
 - o Included the explanation of the process for annual allocations.
 - Introduced a new clause under the progressive reallocation section:
 "Progressive reallocation will not apply in years with extenuating circumstances as agreed by all members."
- On a motion by Sue Gilmore and seconded by David French the CAERC Shared Fiscal and Budget Policy was approved (17 in favor, 0 against).
- Dr. Nye asked what exactly extenuating circumstances means. He reads it as extenuating circumstances that apply to all members, not an individual member with extenuating circumstances. Dr. Gilmore stated it could go both ways and gave the example that COVID-19 is an extenuating circumstance that if affecting everyone. Conversely, as an example for an individual member, Amador could have a forest fire that would only affect the program and should not be penalized for it. Dr. Nye agreed. He suggested in a future iteration to give some examples or define extenuating circumstances to make it clear for all.

- Casandra Issaka informed the group that 21 library locations throughout the region will reopen for limited in person browsing for up to one hour, starting Tuesday, February 9, 2021.
