## **Graduation Ceremonies**

- Twin Rivers held their graduation ceremony on June 1, 2021 at 2 pm. They had 35 students attend the graduation ceremony and they have over 70 graduates in total. This was an increase in graduates compared to last year at 53. The district temporarily lowered the credit requirement to 170 and Tanya Praest is trying to get them permanently lowered for their students. - Galt's graduates will be recognized at a board meeting on June 10, 2021. They had a total of 13 graduates this year which is an increase from the 11 they had last year. Galt recently increased their adult education credit requirements to 200, the continuation school is at 220 credits, and the comprehensive sites are at 280 credits.
- Davis has 4 graduates 2 from earlier in the year and 2 by the end of June. In a non-Covid year they typically have 10-15 graduates. They are doing a personalized graduation ceremony for each graduate with the board trustees, the superintendent, and a small number of their family members.
- Sacramento City is still planning on having their ceremony at the JFK High School stadium on June 23, 2021 at 6 pm. They currently have 84 CTE graduates and expect to have a few more by the end of June.
- San Juan is holding their ceremony on June 10, 2021 at Sunrise Tech Center. They have 30 high school diploma and GED graduates. Each student is allowed 3 guests, but a livestream will also be available.

- EDCOE held their graduation on May 27, 2021. They had 20 graduates and 12 of them walked the stage.
- Natomas is holding their ceremony on June 8, 2021 at Sutter Health Park. Their high school and adult education graduates will be combined. They have 28 graduates this year, but only 8 students opted to walk the stage.
- Elk Grove has 48 high school diploma graduates and 15 high school equivalency graduates. They are not hosting a ceremony this year and instead featured them on social media and mailed them their diploma/certificate and tassel.

#### **CAERC Staffing**

- Branka Marceta made an announcement during our May Business meeting that she will be leaving her position on July 30, 2021. The process has been started to hire a new CAERC director. Renee Collins is working on the hiring process and Angela Hatter has been approved as designated member to participate in the interview with the co-chairs. The interviews will be June 17-18, 2021 and the new director will hopefully start in mid-July to allow for a couple weeks of overlap with Branka.
- Karen Malkiewicz would like the new director to have previous Adult Education experience along with Adult Education experience at the state, local, and regional levels.
- The CAERC director position is open through June 9, 2021.
- Dr. Herota thanked Branka Marceta for taking time off during her trip to continue working on CAERC business and for her years of dedicated support to the CAERC consortium.
