Consortium-Level Deadline to Expend Data & Accountability Funds

- An announcement has been made by the CDE AEO that the problems with Fi\$Cal have been fixed and funds for this year should be arriving soon.
- For CAERC, the Data & Accountability funds needed to be spent, not encumbered, by December 31, 2018.
- A template will be sent out to all members to certify that their Data & Accountability money has been spent. Kiu Chuong will then upload this information, report the expenditures in MIS, and have it certified by the state.

Consortium-Level Deadline to Expend Fund C

- Fund C expenditures -- 2017-18 funds plus any carryover from 2016-17 -- needed to be spent by December 31, 2018. The final fund C expenditure report is due in NOVA by February 1, 2019.
- A template will be sent out to all members to certify that their Fund C money has been spent.
