# **▶** Adult Education Program Updates and Deliverables

- The Adult Education Program (AEP) is now the California Adult Education Program (CAEP) Consortium-Level Deadline: Member Expense Reports
  - The member expense reports for quarter 2 were due February 1, 2019.
  - The 2018-19 funds (Fund D) were released by CDE and checks have been sent to the members. The first check contains 6 installments. The remaining installments will be released on a monthly basis.
  - Members have spent their entire fund C allocations and there will be no re-distribution.

# 2017-18 Program and Expenditure Data by Program Area

- 2017-18 program and expenditure data by program area is due in NOVA on February 15, 2019.
- CASAS has released a software update to fix the duplication issue under Workforce Re/Entry category.

## **Consortium Fiscal Allocation Declaration for 2019-20**

- The CFAD is due May 2, 2019.
- According to the January Budget Proposal, the California Adult Education Program (CAEP) will receive a 3.46% cost-of-living adjustment.

### 3-Year Strategic Plan and Evaluation Report

- The 3-year plan and evaluation report is due June 7, 2019.
- CAERC staff has conducted 3 out of 14 member interviews: Sacramento City, Galt and Los Rios
- A partner engagement event is being planned for Friday, May 10, 2019 and it will be hosted by Los Rios.

### Marketing & Outreach Subcommittee

- The third Marketing & Outreach Subcommittee meeting will be held on Friday, February 22, 2019. John Fleischman will be providing the draft of the ESL video that was filmed in December.
- Please continue to survey your agencies' incoming students about how they've learned about your offerings. So far the top 3 results are: through family, friends, and Google.

### **Director's Workgroup**

- The Director's Workgroup will take place on Friday, February 15, 2019. Members will continue working on the 3-year plan.
- All members are required to participate in business meetings and Director's Workgroup meetings as a condition of receiving funds from the California Adult Education Program (CAEP).

#### **Transition Specialists Workgroup**

- Transition Specialists were invited to attend the North Far North Strong Workforce Regional Consortium event held in January. Center and Sacramento City both sent representatives.
- The workshop focused on 3 main topics: how will the region's CTE programs serve those affected by the wildfires; what systems community colleges have in place when responding to natural disasters and other emergencies; analyzing data in the LaunchBoard Community College Pipeline.

• Cosumnes River College Career Education is hosting a tour of their 9 career education programs on February 22, 2019. Transition Specialists have been invited to attend.

#### **Data & Accountability Workgroup**

- CAERC Data Summary for Quarter 2 was reviewed with members. Student enrollment at the end of quarter 2 is down compared to this time last year at 9 K-12 districts/COEs and up at 4 K-12 districts/COEs.
- K-12 districts/COEs are successfully collecting and reporting student demographics; the rate of post-testing is below the target percentage for 9 K-12 districts/COEs.
- The CAERC Data Summary for Quarter 2 will be discussed during the February 14, 2019
  Data & Accountability Workgroup meeting; members will share their post-testing processes and practices.
